PROGRAMS

DUES INCREASE

NOMINATING COMMITTEE

OTHER BUSINESS

Bessie stated the following AAUW National news/information:

- Branch Donation dollar amounts are not available at this time, therefore the number of Named Honorees has yet to be determined; and
- Bessie discussed AAUW Ashland's donation history to AAUW National. 2018 \$200; 2019 - \$1500; 2020 - \$5000; 2021 - \$0. She requested that Board members consider if a donation is to be made in 2022, and in what amount. Further discussion will be held at the next Board meeting.
