# AAUW ASHLAND BOARD MEETING SEPTEMBER 27, 2021 ZOOM MEETING

Catherine called the meeting to order at 3:30 pm and the following items were discussed:

# **MEMBERSHIP**

Susan Hollandsworth reported that four new members have joined AAUW Ashland, for a total membership of 133 persons.

# **FINANCE**

Jean Conger reported the following: Income - \$7,088; Expense - \$412. Checking - \$13052; Savings - \$3,495; Money Market - \$16,912. Donations are as follows: SOU Endowment - \$409,785; SOU Annual Fund - \$14,905; RCC Endowment - \$117,000, and RCC Annual Fund - \$8,603.

Jean reported that the 990 N Tax form was filed by AAUW National at no cost, and Form CT-12 was filed with the Oregon Department of Justice to maintain the 501(c)(3) status, at a cost of \$50.

Sandra Coyner discussed the reporting of financial accounts and placement of items on specific budget/reporting lines. This reporting method will be discussed by Sandra and Jean, with results given at the next Board meeting.

#### **PUBLIC POLICY**

Regina Ayers reported that Public Policy Team "recruiting" phone calls have been made to the new members, and two of those members have agreed to join the committee. In addition to this new member outreach, a monthly article will be written for the Newsletter.

Regina noted that the January 2022 General Meeting will be devoted to the Public Policy Team program: **Women Leaders Making the Hard Decisions, with** a panel composed of Ashland City Council members discussing the challenges of being an elected official and making policy decisions that impact citizens' daily lives.
