# LAISON REPORTS (attached)

Laison reports have been received from Communications, Interest Groups, Strategic Plan, Scholarship Funding and Membership. Bessie requested a review of the status of the numerous book clubs to determine if the membership would like to increase the number and if so, what type of book clubs would be preferred. #### **MEMBERSHIP**

#### SOUTHERN OREGON HISTORICAL SOCIETY

Paula stated that Ashland AAUW does not have a Historian/Archivist member nor a current location to store archival materials, therefore Paula will research online possibilities. This is especially important for the multiple 5-Star Program awards given to Ashland AAUW.

#### STRATEGIC PLAN

Catherine discussed the status of the Ashland AAUW Strategic plan. All current categories are on track with the exception of **Economic Security.** An Ad Hoc committee is to be formed to both research local economic security issues and to recommend specific steps to the Board. That committee, consisting of Shirley Malcolm, Paula Wiiken, Sandra Coyner and Peggy Audibert, will be asked to survey the membership through an all-member email to determine what issues are critical to be researched then determine one focus to report.

#### **NEW BOARD MEMBER INTRODUCTIONS**

Catherine introduced the following new Board members for the current year: **Shirley Malcom** will chair the Nomination Committee with the help of Catherine Lutes, Gretchen King, and two members to be named later; and Silvie Whitman will chair the Scholarship Campaign in addition to her duties as Interest Group Chair. #### **UPSCALE SALE**

Bessie reported that, due to COVID-19 restrictions, the Spring Upscale Sale has been postponed for the time being. The Fall reservation remains with the Bellvue Grange, and if possible, the date will be determined, and announced in the Vison Calendar. At that time, a Steering Committee of eight members will be created.
